Dog Policy: Dogs must be on leash at all times.

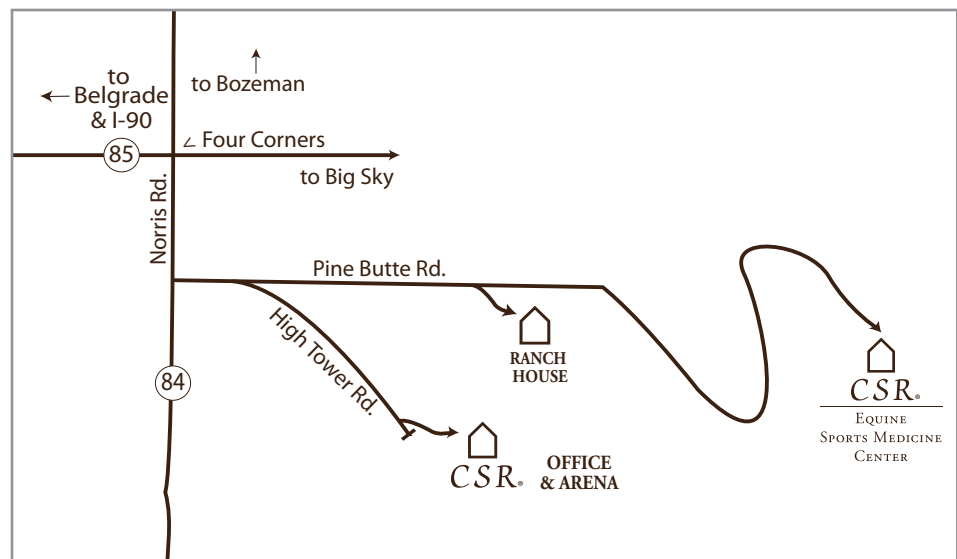
Cancellations: If you can not make it to the clinic you have registered for, you must contact us 7 days prior to the clinic for refund.
